- 2. He/ She must be of 18 years of age.
- 3. Document like Xerox copies of Adhar & voter card/PAN card etc. have to be submitted.
- 4. The bidders must submit certificate of registered firm, valid registration No. PAN Adhar/ any address proof, email address. Contact number, Deeds of partnership business and power of attorney in case of Partnership/ Pvt Ltd. Company, if any.
- 5. Bidder will have to produce all or any documents in original wherever asked by competent authority.
