- iv) PAN card issued by Income Tax Department
- v) Valid I.T.R. (Income tax return) for the latest three consecutive years (2022-23), (2023-24) & (2024-25). To be submitted.
- vi) Latest 3yrs. audited balance sheet including P& L account statements (2022-23), (2023-24) & (2024-25) to be submitted
- vii) Credentials having similar nature of works, Work Order, SOQ and payment certificate of the said work to be submitted.

A partnership firm will have to furnish the registered partnership deed and a company will have to furnish the Article of Association and Memorandum.

Supply Orders and / or Payment Certificates shall not be accepted as Credential. Completion Certificate will be accepted as Credential.

b) Experience / Credential:-

The intending bidders must have completed at least one work of similar nature in a single contract not less than the value of Rs. 40000/-(Rupees Forty Thousand only)in single contracts within last 5 (five) years from the date of NIT.

Payment certificate will not be treated as credential.

NOTE:-

- A prospective bidder shall be allowed to participate in the particular Job either in the capacity of individual or as a partner of a firm. If found to have applied severally for a single job, all his applications will be rejected for that job, without assigning any reason thereof.
- No Mobilization Advance and Secured Advance will be allowed.
- There will be no provision of Arbitration. Settlement of Dispute (refer to Clause no.25 of Form 2911)
- No CONDITIONAL/ INCOMPLETE TENDER will be accepted under any circumstances.
- In case there is any objection regarding prequalifying of an agency, that should be lodged to the Tender Selection Committee, Addl District Mission Director within 48 (forty eighty) hours (working days) from the date and time of publication of list of qualified agencies and beyond that time schedule no objection will be entertained by the Tender Selection Committee
